Points Overview

Earn points for Personal Enrollment Group Volume, Retail Sales through your replicated website, New Enrollments with a pack purchase, and promoting cPRIME at holiday parties. See additional guidelines:

Personal Enrollment Group Volume:

Includes direct enrollees, plus their enrollees, and so on.

New Enrollments:

c3 System Packs include Performance Pack, Lifestyle Pack, and Signature Series Pack.

Example: A new enrollment with a c3 System Pack would earn 25 points + any points generated from BV.

Example: A new enrollment with a Retailer Pack would earn 150 points + any points generated from BV.

Holiday Parties:

Only 2 (two) 25-point submissions allowed per month per distributor during the contest period for a maximum of 100 points (50 points per month). Submit one photo per party. Refer to instructions on how to submit your photos to ensure points are credited accurately.
